TOWN AND COUNTRY PLANNING ACT, 1962

THE COURTY OF EAST SUSSEX (LOUBERCH, DATTLE) TREE PRESERVATION ORDER, 1963

The East Sussex County Council (in this Order called "the Suthority") in pursuance of the powers conferred in that behalf by Section 29 of the Town and Country Planning act, 1962, and subject to the provisions of Section 13 of the Forestry Act, 1951, hereby make the following Order:

1. In this Order -

"the Act" means the Town and Country Planning Act, 1962;

"owner" meens the owner in fee simple, either in possession or who has granted a lease or tenancy of which the unexpired portion is less than three years; a lessee (including a sub-lessee) or tenant in possession, the unexpired portion of whose lease or tenancy is three years or more; and a mortgagee in possession; and

"the Minister" means the Minister of Housing and Local Government.

- 2. Subject to the provisions of this Order and to the exemptions specified in the Second Schedule hereto, no person shall, except with the consent of the authority and in accordance with the conditions, if any, imposed on such consent, cut down, top, lop, or wilfully destroy or cause or permit the cutting down, topping, lopping, or wilful destruction of any tree specified in the First Schedule hereto or comprised in a group of trees therein specified the position of which trees and groups of trees is defined in the manner indicated in the said First Schedule on the map annexed hereto, which map shall, for the purpose of such definition as aforesaid, prevail where any ambiguity arises between it and the specification in the said First Schedule.
 - 3. An application for consent made to the Authority under Article 2 of this Order shall be in writing stating the reasons for making the application, and shall by reference if necessary to a map specify the tree or trees to which the application relates, and the operations for the carrying out of which consent is required.
 - 4. (1) Where an application for consent is made to the Authority under this Order, the Authority may grant such consent either unconditionally, or subject to such conditions (including conditions requiring the replacement of any tree by one or more trees on the site or in the immediate vicinity thereof), as the Authority may think fit, or may refuse consent.
 - (2) The Authority shall keep a register of all applications for consent under this Order containing information as to the nature of the application, the decision of the Authority thereon and any compensation awarded in consequence of such decision, and every such register shall be available for inspection by the public at all reasonable hours.
 - 5. Where the Authority refuse consent under this Order or grant such consent subject to condition they may when refusing or granting consent certify in respect of any trees for which they are so refusing or granting consent that they are satisfied -

(a) that the refusal or condition is in the interests of good forestry; or

(b) that the trees have an outstanding or special amenity value.

6. The provisions set out in the Third Schedule to this Order, being provisions of Parts III and VII of the Act adapted and modified for the purposes of this Order, shall apply in relation thereto.

7. Subject to the provisions of this Order, any person who has suffered damage or has incurred expenditure in consequence of any refusal of consent under this Order or of any grant of any such consent subject to conditions, shall, if he makes a claim on the Authority within the time and in the manner prescribed by this Order, be entitled to recover from the Authority compensation in respect of such damage or expenditure:

Provided that no compensation shall be payable in respect of famage suffered or expenditure incurred by reason

Provided that no compensation shall be payable in respect of damage suffered or expenditure incurred by reason of such refusal or grant of consent in the case of any trees the subject of a certificate in accordance with Fricle 5 of this Order.

- 8. In assessing compensation payable under the last preceding Article or under Section 118 of the Act as applied by this Order account shall be taken of:
 - (a) any compensation or contribution which has been paid in respect of the same trees under the terms of this or any other Tree Prescrvation Order or under the terms of any Interim Prescrvation Order made under Section 8, of the Town and Country Planning (Interim Development) Act, 1943, or any compensation which has been paid or which could have been claimed under any provision relating to the preservation of trees or protection of woodlands contained in an operative scheme under the Town and Country Planning Act, 1932, and
 - (b) any injurious affection to any land of the owner which would result from the felling of the trees the subject of the claim.
- 9. (1) A claim for compensation under this Order shall be in writing and shall be made by serving it on the Authority such service to be effected by delivering the claim at the offices of the Authority addressed to the Clerk thereof or by sending it by prepaid post so addressed.
- (2) The time within which any such claim shall be made as aforesaid shall be a period of twelve months from the date of the decision of the Authority, or of the Minister, as the case may be, or where an appeal has been made to the Minister against the decision of the Authority, from the date of the decision of the Minister on the appeal.

10. Any question of disputed compensation shall be determine in accordance with the provisions of Section 128 of the Act.

11. Any person contravening the provisions of this Order is guilty of an offence under subsection (1) of Section 62 of the Act and liable on summary conviction to a fine not exceeding fifty pounds; and if in the case of a continuing offence the contravention is continued after conviction he is guilty of a further offence thereunder and liable on summary conviction to an additional fine not exceeding forty shillings for every day

on which the contravention is so continued.

12. This Order may be cited as the County of East Sussex (Loxbeech, Battle) Tree Preservation Order, 1963.

SECOND SCHEDULE

This Order shall not apply so as to require the consent of the $\mbox{\sc Authority}$

- (1) to the cutting down, topping or lopping of any tree that is dying or dead or has become dangerous;
- (2) to the cutting down, topping or lopping of any tree -
 - (a) in compliance with an obligation imposed by or under an Act of Parliament;
 - (b) in pursuance of the power conferred on the Postmaster General by virtue of Section 5 of the Telegraph (Construction) Act, 1908:
 - (c) in pursuance of the powers conferred by Section 24 of the Regulation of Railways Act, 1868;
 - (d) for the purpose of preventing or abating a nuisance;
 - (e) in the case of a statutory undertaking where the land on which the tree is situated is operational land as defined by the Act and either works on such land cannot otherwise be carried out or the cutting down, topping or lopping is for the purpose of securing safety in the operation of the undertaking;

THIEFD SCHEDILE

Provisions of Parts III and VII of the Act as adapted and modified to apply to this Order.

22-(1) The Minister may give directions to the authority requiring applications for consent under the Order, to be referred to him instead of being dealt with by the authority.

Reference of applications to the Minister.

- 22-(2) A direction under this section may relate either to a particular application or to applications of a class specified in the direction.
- 22-(3) Any application in respect of which a direction under this section has effect shall be referred to the Minister accordingly.
- 22-(4) Where an application for consent under the Order is referred to the Himseter under this section, the provisions of Articles 4 and 5 of the Order shall apply as they apply to an application which folls to be determined by the authority.
- 22-(5) Before determining an application referred to him under this section the Minister shall, if either the applicant or the authority so desire, afford to each of them an opportunity of appearing before, and being heard by, a person appointed by the Minister for the purpose.
- 22-(6) The decision of the Minister on any application referred to him under this section shall be final.

Appeals against decisions.

- 23-(2) A notice under this section shall be served in writing within twenty-eight days from the receipt of notification of the decision, certificate or direction, as the case may be, or such longer period as the Minister may allow.
- 33-(4) Where as appeal is brought under this section from a decision, contificate or direction of the authority; the Minister, subject to the following provisions of this section, may allow or discuss the appeal, or may reverse or vary any part of the decision of the authority, whether the appeal relates to that part thereof or not, or may cancel any certificate or cancel or vary any direction, and may deal with the application as if it had been made to him in the first instance.
- 23-(5) Before determining an appeal under this section, the Minister shall, if either the appellant or the authority so desire, afford to each of them an opportunity of appearing before, and being heard by, a person appointed by the Minister for the purpose.
- 23-(7) The decision of the Minister on any appeal under this section shall be final.
- 24. Where an application for consent under the Order is made to the authority, then unless within two months from the date of receipt of the application, or within such extended period as may

Power to nevel to or modify the conduct under the order.

- 27-(1) If it appears to the authority that it is expedient to revoke or application made under Article 3 of the Order, the authority may by order revoke or modify the consent to such extent as they consider expedient.
- 27-(2) in order under this section shall not take effect unless it is condimised by the Minister; and the Minister may condiminary such order submitted to him either without modification or subject to such modifications as he considers expedient.
- 27-(3) Where an authority submit an order to the Minister for his conditionation under this section, the authority shall furnish the Minister with a statement of their reason for making the order and shall serve notice on the owner of the land affected, and an any other person who in their opinion will be salected by the order, and if within the period of twenty-eight days from the service thereof my person on whom the notice is directly as a required, the Minister, before confirming the order, shall affect to that person, and to the authority, an apportunity of appearing before, and being heard by, a person appointed by the Minister for the purpose.
