**Request/Response**

**1. How many children’s playgrounds were managed by the local authority in each year from 2009-10?**

‘Play area’ is interpreted as being an equipped, public outdoor play area. It excludes skateparks, basketball hoops and pads, outdoor gym equipment and kickabout goals. The only difference in the figures between 2009-10 and the current time is as a result of the addition of the seafront (West Parade) facilities in 2011 and loss of the old swings and slide at St. Mary’s Recreation Ground, Bexhill in 2016-17.

2. How many children's playgrounds (existing or planned) have been closed or cancelled because of cuts to the local authority's budget in each year since 2009-10?

One. A play facility comprising just a set of swings and a slide was removed in 2016-17 as the expenditure needed to install new safety surfacing around the two items could not be justified. The items of play equipment were themselves very old, albeit still safe to use. The decision was not purely financial; it also took other factors into consideration including the proximity of an alternative local facility and the limited value and use of the existing facility.

A single swing at a different open space (Broad Oak Park) was removed in 2009-2010 due to rusting at the base. It was the only piece of equipment on the site and couldn't be considered a play area as such. The decision not to replace it was not taken due to financial reasons.

3. How much local authority money has been spent on children's playgrounds in each year since 2009-10?

Note that the Council doesn't not have a dedicated budget for public children's play areas. Expenditure for play areas comes out of a general budget for parks and open spaces and therefore expenditure varies from year to year depending on what other work needs to be dealt with.

The amount spent on children's play areas in each year since 2009-10 is broken down by:

- money has been spent on maintenance of existing areas and
- money has been spent on building new areas.

The costs provided in relation to 'maintenance' include expenditure on refurbishment and the replacement of individual items of equipment and repairs as well as routine safety inspections, grass cutting and bin emptying within play areas. Litter picking is not included as this is calculated for entire sites and most play areas are just a small part of these bigger sites. The money spent includes funding secured through external grant providers as well expenditure through the council's own capital and revenue budgets. The costs relating to 'new' exclude refurbishment works.
