#### SEDLSCOMBE NEIGHBOURHOOD PLAN 2016-2028

#### Regulation 16 of The Neighbourhood Planning (General) Regulations 2012



Sedlescombe Parish Council, as the qualifying body, has prepared a Neighbourhood Plan for its parish. The Plan proposes a vision for the parish and a number of planning policies to be used in the determination of planning applications locally.

Copies of the Sedlescombe Neighbourhood Plan and supporting documents will be available for public inspection for eight weeks commencing 9am on the **28th November 2016 and ending on the 23rd January 2017.**

All representations must be received by the Council **no later than 5pm on Mon 23rd January 2017**. Any submissions received after this deadline cannot be considered.
