## THE DISTRICT OF ROTHER (DISTRICT OF ROTHER OFF-STREET PARKING PLACES ORDER 1983) (VARIATION NO. 11) ORDER 2010



NOTICE is hereby given that ROTHER DISTRICT COUNCIL has made the above Order under the Road Traffic Regulation Act 1984 to vary the DISTRICT OF ROTHER OFF-STREET PARKING PLACES ORDER 1983 as varied by THE DISTRICT OF ROTHER (DISTRICT OF ROTHER OFF-STREET PARKING PLACES ORDER 1983) (VARIATION NO. 10) ORDER 1993. The Order comes into operation on 19 June 2010.

The effect of the Order will be to extend the provisions of the 1983 Order (as varied by the No 10 Order) to three new car parks as follows:

- New Lydd Road, Camber (formerly the Arnold Palmer Putting Green). The charges (which will apply to both towing and towed vehicles separately) will be from 1 May 30 September: £1.50 up to 1 hour; £3.00 for 1-2 hours; £5.50 for 2-4 hours; £7.00 for 4-6 hours; £9.50 for 6-8 hours; £10.00 for 8-10 hours and from 1 October 30 April: £1.00 up to 1 hour; £2.00 for 1-2 hours; £3.00 for 2-4 hours; £4.00 for 4-6 hours; £4.00 for 6-8 hours;£4.00 for 8-10 hours and on all days: for stays over 10 hours and/or including any period between 2000 and 0830 Standard Charge of £80.
- 2. At The Grove Rye there will be a car park associated with the Swimming Pool allowing some Rye Community Primary School use (up to 30 minutes free on school days between 0800 and 0900 and between 1500 and 1600) AND an adjacent car park primarily for the School where use for the Swimming Pool will be allowed when the School does not need the facility. At all other times the charges for both car parks will be: £2 for up to 1 hour; £3 for 1-2 hours; £6 for 2-4 hours; £10 for over 4 hours; no overnight stays.

if any person wishes to question the validity of the Order or of any of its provisions on the grounds that it or they are not within the powers conferred by the Act, or that any requirement of the Act or of any instrument made under the Act has not been complied with, that person may, within 6 weeks from the date on which the Order was made, apply for the purpose to the High Court.
