THE BOROUGH OF RYE (CAMBER CASTLE ESTATE NO.2) DIRECTION 1973

MHEREAS the Rye Borough Council acting on behalf of the County Council of the Administrative County of East Sussex being the local planning authority for the said County are satisfied that it is expedient that the development of the descriptions set out in the Schedule hereto should not be carried out on approximately 11.3 hectares at or near Rye Harbour Road (formerly part of the Camber Castle Estate) in the Borough of Rye and shown hatched black on the plan attached to this Order unless permission therefore is granted on application made junder the Town and Country Planning General Development Order 1973

NOW THEREFORE the said Rye Borough Council in pursuance of the powers conferred upon then by article 4(1) of the Town and Country Planning General Development Order 1973 HEREBY DIRECT that the permission granted in article 3 of the said Order shall not apply to development of the said land of the descriptions set out in the Schedule hereto

SCHEDULE

- VI(1) The carrying out on agricultural land having an area of more than one acre and comprised in an agricultural unit of building or engineering operations requisite for the use of that land for the purposes of agriculture (other than the placing on land of structures not designed for those purposes or the provision or alteration of dwellings)
- VII The carrying out on land used for the purposes of forestry (including afforestation) of building and other operations (other than the prevision or alteration of dwellings) requisite for the carrying on of those purposes, and the formation, alteration and maintenance of private ways on such land.
- XXII The use of land, other than a building, as a caravan site in any of the circumstances specified in paragraphs 2 to 9 (inclusive) of Schedule 1 to the Caravan Sites and Control of Development Act 1960, or in the circumstances (other than those relating to winter quarters) specified in paragraph 10 of the said Schedule
