

## ROTHER DISTRICT COUNCIL

### TOWN AND COUNTRY PLANNING ACT 1991

## DIRECTION UNDER ARTICLE 4 OF THE TOWN

AND COUNTRY PLANNING GENERAL DEVELOPMENT ORDER 1988 (AS AMENDED)

WHEREAS the Council of the District of Rother being the local planning authority for the said District are of the opinion that development of the descriptions set out in the Schedule hereto should not be carried out on any land at Rye East Sussex being the land shown edged red on the plan annexed hereto unless permission therefor is granted on application made under the Town and Country Planning General Development Order 1988.

AND WHEREAS the Council are further of the opinion that development of the said descriptions would be prejudicial to the proper planning of their area and would constitute a threat to the amenities of the area and that the provisions of paragraph 5(4) of the said Article 4 should apply to this direction.

NOW THEREFORE the said Council in pursuance of the powers conferred upon them by the said Article 4 direct that the permission granted by Article 3 of the Town and Country Planning General Development Order 1988 shall not apply to development on the said land of the descriptions set out in the schedule hereto.

THIS DIRECTION is made in pursuance of the provisions of paragraph 5(4) of the said Article 4 and shall remain in force until 15th October 1991 (being 6 months from the date of this Direction) and will then expire unless it has been approved by the Secretary of State for the Environment before that date.

THIS DIRECTION may be cited as the Rother District Council (Rye Town, East Sussex) Article 4 No. 1 Direction 1991.

#### SCHEDULE

The installation, alteration or replacement of a satellite antenna on a dwellinghouse or within the curtilage of a dwellinghouse; being development comprised within Part 1 Class H referred to in the Second Schedule to the said Order, and not being development within any other Class.
