

## ENFORCEMENT NOTICE - MATERIAL CHANGE OF USE

**IMPORTANT - THIS COMMUNICATION AFFECTS YOUR PROPERTY**

**TOWN AND COUNTRY PLANNING ACT 1990**  
 (as amended by the Planning and Compensation Act 1991)

**ENFORCEMENT NOTICE - A**

**ISSUED BY:** Rother District Council

1. THIS NOTICE is issued by the Council because it appears to them that there has been a breach of planning control, within paragraph (a) of section 171A(1) of the above Act, at the land described below. They consider that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The Annex at the end of the Notice and the enclosures to which it refers contain important additional information.

**2. THE LAND TO WHICH THE NOTICE RELATES**

Land opposite The Croft, Moat Lane, Sedlescombe, East Sussex shown edged red on the attached plan.

**3. THE MATTERS WHICH APPEAR TO CONSTITUTE THE BREACH OF PLANNING CONTROL – MATERIAL CHANGE OF USE**

Without planning permission a material change of use of the land from agriculture to a mixed use for agriculture and equestrian use of the land.

**4. REASONS FOR ISSUING THIS NOTICE**

It appears to the Council that the above breach of planning control has occurred within the last ten years.

The unauthorised development has caused harm to the landscape character of the High Weald AONB, contrary to Policies OSS4 (iii) and EN1 (i) of the Rother district Local Plan Core Strategy. The use of the land is personal and there is no justification for, or circumstances to warrant the material change of use.

The Council do not consider that planning permission should be given, because planning conditions could not overcome these objections.

**5. WHAT YOU ARE REQUIRED TO DO**

- i) Cease the use of the land for equestrian activities.
- ii) Return the land to its former agricultural condition prior to when the breach took place, being grassed pasture.
- iii) Remove all materials, rubble, rubbish, debris, tools and equipment from the land arising from compliance with the steps above.

## 6. TIME FOR COMPLIANCE

Two months after this notice takes effect.

## 7. WHEN THIS NOTICE TAKES EFFECT

This notice takes effect on 12 June 2017 unless an appeal is made against it beforehand.


