

ENFORCEMENT NOTICE - MATERIAL CHANGE OF USE



IMPORTANT - THIS COMMUNICATION AFFECTS YOUR PROPERTY

ENFORCEMENT NOTICE

ISSUED BY: Rother District Council

1. THIS NOTICE is issued by the Council because it appears to them that there has been a breach of planning control, within paragraph (a) of section 171A(1) of the above Act, at the land described below. They consider that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The Annex at the end of the Notice and the enclosures to which it refers contain important additional information.

2. THE LAND TO WHICH THE NOTICE RELATES

Land at Greenacres Holding, Loose Farm Lane, Battle, East Sussex shown edged red on the attached plan.

3. THE MATTERS WHICH APPEAR TO CONSTITUTE THE BREACH OF PLANNING CONTROL

Without planning permission a change of use of the land from agriculture to a mixed use comprising agriculture and the stationing of a residential caravan and use thereof for human habitation.

4. REASONS FOR ISSUING THIS NOTICE

It appears to the Council that the above breach of planning control has occurred within the last four years.

The site is outside any development boundary identified in the Rother District Local Plan and the use of the land for the siting of a residential caravan does not satisfy the requirements of Policies HG5 and GD1(iv) and (v) of the Plan.

The Council does not consider that planning permission should be given, because planning conditions could not overcome these objections.

5. WHAT YOU ARE REQUIRED TO DO

Discontinue the use of the land for human habitation and remove the caravan and all domestic items from the land.

6. TIME FOR COMPLIANCE

Three months after this notice takes effect.

7. WHEN THIS NOTICE TAKES EFFECT

This notice takes effect on 10 November 2013 unless an appeal is made against it beforehand.



Failure to comply with an enforcement notice which has taken effect can result in prosecution and/or remedial action by the Council.
